## DIRECTOR'S REPORT SPORTS ACTIVITIES – DAN KOVACS 1/2



### **Carp Outdoor Rink (ODR)**

- WC Outdoor Youth Hockey League primary user of the rink
- HCA provided free weekly use to ringette players, families and shinny players in 2020
- COVID restrictions = no youth league games in 2021

#### **ODR Pickleball**

- The City funded the painting of two additional courts - we now have 4 courts
- HCA registered 40 individuals in 2020 and 100 in 2021

#### **Soccer Fields**

 COVID restrictions = no youth or adult league games – however HCA rented the fields to the WCSC competitive youth teams for practices and scrimmages.

## DIRECTOR'S REPORT CARP RIVERWALK – DOUG ROTHWELL





- Partnership between the HCA and Friends of the Carp River (FCR).
- Agreement is in keeping with the City's Contribution
   Agreement and the Commemorative Integrity Statement of the Diefenbunker National Historic Site.
- Trail is part of the Carp Community Design Plan
  - All season, multi purpose trial
  - Opened November 2020
  - Consists of two loops: I km and 2 km
  - Located on City property bordered by the Diefenbunker, Craig Side Road and Carp river
  - Pedestrian access available from village near Library parking lot and from Mess Hall and Craig Side Road.
- Planning underway for Service Agreement with City.
- All future developments such as City approved signage, picnic benches, interpretive and welcoming signs are contingent upon this agreement.

## **DIRECTOR'S REPORT**CARP SOFTBALL/BALL DIAMONDS – GEOFF LATHEM 1/3



- Financial assistance received from City of Ottawa, a Community Partnership minor capital grant. Construction supplies and materials from local companies. We have:
  - Done major upgrades on both Ball diamonds
  - Diamond 2 Replaced outfield fence and 3rd baseline fence
  - Replaced existing dugouts on both diamonds with covered dugouts with metal roofs
- 900 volunteer hours to date.

## **DIRECTOR'S REPORT**NEW STORAGE SHED – JIM COLLINGS 1/2



- Several storage options were considered.
- Impetus to consolidate general storage into one location to reduce rental costs (\$3000/year).
- New unit is an Amish shed, 10' x 20' similar to Burger Booth.
- To be positioned east of the ODR building toward Ball Diamond #1.

- Cost of new storage unit is \$4100 plus tax.
- Delivery late May / early June.
- Additional costs include granular base, steel doors and interior shelving.
- Total cost \$7000 plus tax.



## HCA STRATEGIC PLANNING PROCESS OVERVIEW...










#### **Article 2: Objectives**
